

GENERAL INSTRUCTIONS

- (i) Eligibility: As per the UGC Regulations 2018/ HNB Garhwal University (Central University)/State Government.
- (ii) Pay Scale: For Principal is as per UGC Regulations 2018 (Pay Scale 144200-218200 - Level-14)
- (iii) A non-refundable Application fee of Rs.5000/- (Rs. Five Thousand only) is required to be submitted along with the Application form. Applicants should submit it through a Demand Draft of any nationalized bank drawn in favour of the Principal D.A.V (P.G.) College, Dehradun.
- (iv) Applications completed in all respects in the prescribed format may be sent to the Dayanand Shiksha Sansthan (UP) Kanpur, 15/96, Civil Lines Kanpur - 208001 through Speed Post, up to 10-June 2026 by 5.00 P.M. strictly.
- (v) The term of Appointment of the Principal shall be for Five Years as per UGC Regulations 2018.
- (vi) Only the shortlisted candidates will be called for the Interview.
- (vii) Screening & Shortlisting of Candidates for the Interview: Screening and Shortlisting of candidates for the interview will be done as per UGC Regulations 2018.
- (viii) Minimum Qualifications: As prescribed by UGC Regulations 2018/ HNB Garhwal University (Central University)/State Government.
- (ix) The date of interview shall be communicated to the short-listed Candidates by Email/Mobile/Speed Post.
- (x) Candidates belonging to SC/ST/OBC category should submit proper caste certificate as per requirements of the State Government.
- (xi) Candidates must ensure before applying that they are eligible according to the criteria stipulated in the advertisement. If the candidate is found to be ineligible at any stage of the recruitment process, he/she will be disqualified and their candidature will be cancelled. Submitting false information will lead to cancellation of candidature at any stage of recruitment.
- (xii) Any Legal proceedings in respect of any matter of claim or dispute arising out of this advertisement can be instituted only in the High Court of Judicature at Nainital.

- (xiii) The College reserves the right to Revise/Reschedule/Cancel/Suspend the recruitment process or withdraw partial or full advertisement without assigning any reason.
- (xiv) The Candidate must attach self-attested copies of all the relevant testimonials and documents. The original Certificates would be required at time of interview only.
- (xv) Applications not accompanied with prescribed fee or incomplete applications in any respect or without the requisite documents will be summarily rejected.
- (xvi) The employed candidates of Govt./Private Universities/Colleges/Institutions/Autonomous bodies should send the applications through proper channel. However, they may produce the NOC from their organization at the time of the interview with an unambiguous certificate that (i) no vigilance case is pending/being contemplated. (ii) the candidate has never been penalized for any unlawful activity earlier.

- (xviii) The College shall not be responsible for any delay/loss due to postal or technical reasons.
- (xix) Canvassing in any form will be treated as a disqualification for the post.
